4. Correspondence

Email was received from Stephen Cos – Dynamo Cycling Club on June 7, 2023

- i. Communication it was suggested that RTX Council could advise clubs 2 weeks in advance of meetings so any items for discussion could be sent in, and that minutes could be sent to all clubs within 2 weeks for the council meetings.
 - In previous years, the schedule of meeting was published with the post AGM minutes. This is to be reinstated, and a separate schedule published/circulated so all clubs can know in advance when meeting are scheduled and have chance to send in items for discussion. It is intended that the schedule and a reminder will be posted on the RTX Facebook page. Minutes: following a RTX council meeting the minutes are to be checked, confirmed by Council via Email, and once OK circulated and posted on the CNZ website and posted on the RTX Facebook page. The Minutes will still be approved at the next RTX meeting.
- ii. AGM Levy It was suggested that each club could pay an Annual AGM levy so future AGM could be held in person.
 - It was noted that in person connections/meetings are better however online AGM's are the way to go now, given it is a lesser commitment and a better use of peoples time.
 - It was suggested that it to ensure the in-person connections are maintained / reestablished, RTX need to find other times to connect. It was suggested that SGM's be held at events already planned during the year. It will be encouraged for each code Road, Track CX and Gravel to hold meetings / Workshop at events during the year and any feedback brought back to RTX council.

- iii. Membership Database If CNZ are not taking responsibility for some national championship events, then we should have the member database available to help promote these events.
 - It was agreed that the availability of the membership database should be part and parcel of the RTX information available to race organizers/and Clubs running a RTX event. The RTX council and members need access to this information.
- iv. AGRN There seems to be a continuing problem with riders taking part in the Elite Champs and then the AGRN it was suggested that for AGRN the categories of open /Elite be in age groups i.e. 19-24, 25-29, 30-34, and hat these age groups along with U19 race together and have separate medals. This would stop any of the riders from GRN claiming to be "national Road Champion"

After discission it was decided to leave as Council was only aware of this happening a few years ago and it does not seem to be as big an issue anymore.

Crit nationals – RTX Support SS to run event; RTX - CNZ Collaboration with SS. SS has applied to Local City Council for funding to run event – if sponsorship is nt found, the event \$ cannot be run.

Gravel & Tar – The application to run the event both Men and Women has been lodged via CNZ

AGRN – Email from Stephen Cox dates June 6, 2023 – RTX advised the database should be made available.

It was noted that if information can be published on multiple FB pages at the same time if admin rights are given for social media Take overs. This would ensure the AGRN And RTX Facebook pages are sharing the same information

Elite RN – In Progress with CSC; funding people are getting together to ensure that are all not applying for the same money; Course – same as 2023 AGRN, with some updated logistics; Looking at new Start/finish area given that the event is during the school term. RS to Follow up when it will be announced.

Track Nationals – Date / location – RS to follow up with CC; CC advised RS that due travel costs, Invercargill would not be considered for 2024. The timing of the event, given the cross over with rowing events is still being considered with in the week in question i.e. considering Monday to Friday however CNZ have advised that the date will not be changed. It was noted the date of the second 2024 Track Nations Cup is still to be confirmed

Masters Track – RS soke with Tomo, and has been advised of the dates and will book the Track.

Selections – JW, Worlds (Road) etc – PH: Very Late sections notifications. SS has made it very clear with RH that late selection makes it very hard for parents to get funding when selections are announced at late notice. Pressure hd been put on to get selection out earlier in the piece. However, little can/has been done for 2023 and the pressure should to continue to ensure a longer lead is made for 2024. There is no need to wait until the last minute for selection.
