# UCI Cycling Esports World Championships Entry Allocation Process


## 1. General Selection Regulation and this Schedule

- 1.1 This Schedule 5 is a schedule to the Cycling New Zealand General Selection Regulation (last updated 10 April 2024) (General Selection Regulation) for selection of the 2024 UCI Cycling Esports World Championships.
- 1.2 Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

#### 2. Introduction and Quota

2.1 The 2024 UCI Cycling Esports World Championship will consist of a qualifying round (referred to as the "semi-final") and a final. 150 riders will compete in the semi-final with the top 20 riders from both the men's and women's races making it to the final, to be hosted in Abu Dhabi. Of the 150 riders in each category, 120 will be selected by their Federations, with MyWhoosh providing the opportunity for 30 riders to qualify from the community.

# 3. Eligibility Requirements

- 3.1 All riders seeking entry to the Cycling Esports Team must complete the Rider Application by providing all information requested in the online Rider Application by the date set out in clause 5 below.
- 3.2 All athletes who compete in the World Championships on MyWhoosh must undergo MyWhoosh's independent verification process and have a MyWhoosh Power Passport.
- 3.3 Riders allocated an entry for the semi-final will need to use their own smart trainer, that must meet all MyWhoosh requirements.

## 4. Qualification Event

4.1 New Zealand has been allocated the following quota by the UCI for the semi-final:

Men: 4 places Women: 4 places

- 4.2 Cycling New Zealand will host a single qualifying event on <u>Saturday</u>, 6 <u>July</u>. Information about this event can be found on the Cycling New Zealand website:

- 4.3 The allocation of quota will be as follows:

  The top four (4) men and the top four (4) women, at the conclusion of the Cycling New

  Zealand qualification race will be awarded the entry to the 2024 UCI Cycling Esports World

  Championships.
- 4.4 At the discretion of the selection panel, quota not accepted by those who qualify through clause 4.3, may be rolled down to the fifth placed rider in each category.
