

Cycling New Zealand - Selection Regulation
Schedule 1 – Track (Elite)
Selection for UCI 2025 Track World Championships
Date of Issue – 31 January 2025



1. General Selection Regulation and this Schedule

- 1.1 This Schedule 1 is a schedule to the Cycling New Zealand General Selection Regulation (last updated 22 December 2024)([General Selection Regulation](#)) for selection of the Elite Track Team to the 2025 UCI Track World Championships.
- 1.2 Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Every reference to a rider in this Schedule means an Eligible rider, unless stated otherwise. Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objectives

- 2.1 Cycling New Zealand's selection objectives for the 2025 UCI Track World Championships are in order of priority:
 - a. to win as many medals as possible in team and/or individual events;
 - b. to provide competition opportunities for those riders who have the greatest potential in the next two years to win medals at Pinnacle Events, and Commonwealth Games;
 - c. to enable the collection of UCI points to qualify for future International Competitions; to assess riders competing in differing roles and for other strategic and tactical reasons which may contribute to their future success.

3. Eligibility Requirements

- 3.1 In order to be Eligible, all riders seeking selection to the Elite Track Team must complete the Rider Application by the date set out in clause 6 below.

4. Selection Criteria

- 4.1 The Selection Panel will select riders it considers:
 - a. are capable of achieving the Selection Objective in clause 2.1, or
 - b. meet the Selection Objective in clauses 2.1b; or
 - c. are capable of assisting CNZ to achieve the Selection Objective in clause 2.1c.
- 4.2 The Selection Panel must consider riders' results and performances at a 2025 UCI Track Nations Cup, 2025 Oceania Track Championships and any UCI C1 Track Events in the Performance Window (see clause 6 below), giving weight to achievement of the Performance Standards in Table 1(below) at any one or more of those competitions.

- 4.3 Additionally, the Selection Panel may consider:
- a. any one or more of the Discretionary Considerations (see clause 5 below); and,
 - b. any [Extenuating Circumstances](#), injury, illness or other factors (in accordance with clause 7 of the General Selection Regulation).

These standards are a guide to contextualize performances indicative of World Championship medal capability and are neither minimum standards nor will result in automatic selection. These standards may be updated by amendment of this Schedule to reflect the rate of progression of international competition.				

5. Discretionary Considerations

- 5.1 The Selection Panel may consider any other factors and information it considers relevant to decide on the riders to select, including:
- a. a rider's progress towards their agreed individual performance objectives (such as in IPPs or similar), including how the rider has progressed against individual and event targets;
 - b. a rider's ability to win a medal in more than one Event;
 - c. a rider's ability to contribute to a performance in team Events (including Madison);
 - d. the conditions in which results and performances were obtained, including but not limited to the nature of the velodrome, equipment used, environmental conditions, team composition, and/or level /field of competition;
 - e. the rider's results and performances outside of the competitions listed in clause 4.2, including in-competition, training, or trials, within the Performance Window;

- f. the results of a rider’s testing, assessment, training and other data collected both in and out of competition, during the Performance Window;
- g. the number and nature of Events in which a rider may compete at the 2025 UCI Track World Championships;
- h. a rider’s attendance and conduct at past competitions, training sessions, training camps, testing sessions, assessments, and other events;
- i. a rider’s performance behaviours, including active engagement in individual performance planning (IPP) or similar process, attention to detail, and ability to perform under pressure; and
- j. the extent to which a rider has planned, and is committed to seeking, to compete in the 2025 UCI Track World Championships; has actively engaged with CNZ and is aligned with the Selection Objectives, including their reasons for wishing to be selected.

5.2 **Relevance & Weight:** The Selection Panel has absolute discretion to determine the relevance and weight of any of the Discretionary Considerations and any Extenuating Circumstances, illness, injury or other factors (under clause 4.3b), as it sees fit.

6. Key Timelines

The Elite Track Team will be selected in accordance with the Key Timelines set out below, unless Cycling New Zealand needs to change those dates for reasons outside of its control.
