Cycling New Zealand - Selection Regulation



Schedule 1A -Track - Junior (U19) Selection for 2025 UCI Junior Track World Championships Date of Issue - 22 December 2024

1. General Selection Regulation and this Schedule

- 1.1 This Schedule 1A is a schedule to the Cycling New Zealand General Selection Regulation (last updated 22 December 2024)(General Selection Regulation) for selection of the Junior Track Team to the 2025 UCI Junior Track World Championships.
- 1.2 Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Every reference to a rider in this Schedule means an Eligible rider, unless stated otherwise. Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objectives

- 2.1 Cycling New Zealand's objectives for the 2025 UCI Junior Track World Championships are to select Junior riders it considers:
 - a. are demonstrating potential for medal success at future Pinnacle Events in Elite Track classes and.
 - b. will benefit from the development opportunity of competing at this level of competition.

3. Eligibility Requirement

- 3.1 In order to be Eligible, all riders seeking selection to the Junior Track Team must complete the Rider Application in the Rider Application Period set out in clause 6 below.
- 3.2 It is a condition of selection that riders may be required to fund or partially fund themselves to attend and compete at the 2025 UCI Junior Track World Championships; and,
- 3.3 Additionally, riders are required to fund any competitions from which their results may count towards achieving selection. (See clause 8 of the General Selection Regulation for conditional selections).

4. Selection Criteria

- 4.1 In considering which riders satisfy the Selection Objectives, the Selection Panel:
 - 4.1.1 must give primary weight to riders who meet the Primary Performance Standards (in Table 1 below), in the Junior (U19) category at the 2025 Oceania Track Championships or the 2025 New Zealand Track Championships;
 - 4.1.2 must then consider riders who meet any of the Secondary Performance Standards (in Table 1 below), in the Junior (U19) category at the 2025 Oceania Track Championships or the 2025 New Zealand Track Championships;
 - 4.1.3 may consider any one or more of the Discretionary Considerations (in clause 5 of this Schedule); and
 - 4.1.4 may consider any Extenuating Circumstances, injury, illness or other factors (in accordance with clause 8 of the General Selection Regulation).

These performance standards are a guide to indicate the performance required to be competitive at the 2025 Junior World Championships and support the Selection Objectives. These Performance Standards are neither minimum standards nor will result in automatic selection.

5. Discretionary Considerations

- 5.1 The Selection Panel may consider any other information it considers relevant in considering the riders to select, such as:
 - a rider's ability to train and compete with others to fulfil a specific role in team events
 (e.g. Team Pursuit, Team Sprint, and Madison);
 - b. a rider's performances in bunch, keirin and sprint races demonstrated at any competition within the Performance Window;
 - c. meeting the performance standards (Table 1) in competitions outside of those listed in Table 1, within the Performance Window;
 - d. the conditions in which results and performances were obtained, including but not limited to: the nature of the venue, equipment used, environmental factors, team composition, and level of competition;
 - e. the number and nature of Events in which a rider may compete at the 2025 UCI Junior Track World Championships;
 - f. a rider's attendance, and conduct at past competitions, training sessions, training camps, testing sessions, assessments, and other events.
- 5.2 **Relevance & Weight:** The Selection Panel has absolute discretion to determine the relevance and weight of any of the Discretionary Considerations and any Extenuating Circumstances, injury, illness or other factors (under clause 4.1.4) as it sees fit.

6. Key Timelines

The Junior Track Team will be selected in accordance with the Key Timelines set out below, unless Cycling New Zealand needs to change those dates for reasons outside of its control.
